JOB SUMMARY:

Tri County Health Network is looking for behavioral health teletherapists to provide high quality, compassionate and ethical outpatient mental health therapy for students from several rural Colorado school districts, with the potential to expand services to adult clients. Therapists, operating as independent contractors, will treat clients via live HIPAA compliant videoconferencing, using the same techniques and approaches as traditional in-person therapy. The online solution includes high-fidelity audio and video for live interactions, scheduling tools, and will allow therapists to work with clients to solve on-going behavioral health concerns.

DUTIES AND RESPONSIBILITIES:

May include the following, and other duties as assigned.

- 1) Utilize a variety of treatment approaches to work with a diverse population of children, adolescents, families, and adults.
- 2) Conduct client screenings and diagnostic assessments.
- 3) Work with clients to identify treatment goals and objectives.
- 4) Maintain accurate and timely clinical records consistent with TCHNetwork standards.
- 5) Communicate with primary care and/or behavioral health staff as appropriate and necessary to ensure continuity of care.
- 6) Use scheduling software for follow-up client services.
- 7) Maintain good standing with the appropriate board and insurance entities.
- 8) Stay current with updated research and best practices.
- 9) Be aware of community referral sources and refer to outside providers when necessary.
- 10) Maintain client confidentiality including securing client information per HIPAA standards.

QUALIFICATIONS:

- 1) Master's level degree in one of the recognized mental health professions.
- 2) Colorado State License or License eligible.
- 3) Working knowledge of individual, group, and family treatment approaches and their application to clients with emotional, behavioral, and substance use disorders.

- 4) Working knowledge of behavioral medicine and evidenced-based treatments for medical and mental health conditions.
- 5) Ability to work through brief client contacts as well as to make quick and accurate clinical assessments of mental and behavioral conditions using a web-based tele therapy system.
- 6) Training in conducting diagnostic evaluation to establish differential diagnosis and treatment plans.
- 7) Experience in an integrated model or primary care clinic preferred.
- 8) Experience with video conferencing systems and/or an ability to easily troubleshoot difficulties with technology

REQUIREMENTS:

- 1) Therapists will be required to supply their own web-capable computer system, with web camera and speakers to deliver services using our tele therapy platform over high speed internet connections.
- 2) Available for scheduling M-F, 8:30-3:00 PM. Must be available for at least 1, 3-hour shift per week. Shifts generally shifts are from 8:30-11:30 and 11:30-2:30.
