JOB SUMMARY:

The Food Bank Coordinator is responsible for assisting regional food pantries increase participants and provide an inclusive space for diverse community members, including Latinx, seniors, and people of all income levels.

DUTIES AND RESPONSIBILITIES:

May include the following, and other duties as assigned.

- 1. Provide support to food bank staff and volunteers, as able.
- 2. Manage TCHNetwork volunteer programming effort including recruiting, growing, and organizing volunteers.
- 3. Identify best practices to increase efficiencies and sustainability through review of existing policies and procedures, workflows, and onsite review of operations.
- 4. Research best practices to create an inclusive and welcoming space that is accessible to all participants.
- 5. Outreach and engage Latinx community to assess and address their needs.
- 6. Assist in the creation of the marketing and outreach campaign to increase participation by community members most in need, including adults 65+, Latinx, and low-income families including translation of materials.
- 7. Serve as the liaison between regional food banks, helping to increase collaboration, and implementing best practices for resource sharing.
- 8. Assist in the creation of a workplan to implement identified best practices for each food bank.
- 9. Support the implementation of components of the adopted workplan.
- 10. Coordinate with the Norwood Fresh Food HUB, Westend Family Link, and the Local Food Initiative.
- 11. Attend Food Security Coalition meetings.
- 12. Assist in developing a succession plan for the food banks.
- 13. Assist with program support and outreach that address health equity, including becoming a trained facilitator, as requested.
- 14. Translate TCHNetwork marketing and promotional materials into Spanish
- 15. Other duties as required to ensure the success of the programming and TCHNetwork.
